

Not illustrated. 1918 Excerpt: . of June 7, 1917, has applied to the commission for a payment on account of the work done; and Whereas, The Chief Engineer of the Commission has reported under date of June 14, 1917, that more than three-quarters of the work has been finished; Now, therefore, it is Ordered, That an intermediate settlement be had in these proceedings and that a hearing be had on the 11th day of July, 1917, at 2:30 o clock in the afternoon, at the rooms of the Commission, No. 120 Broadway, Borough of Manhattan, City of New York, for a consideration of the expenditures made in these proceedings. Further ordered. That notice of this hearing be given to the Staten Island Rapid Transit Railway Company and to The City of New York at least five days prior to the date of said hearing.
